

## Notes

This device is a headgear primarily intended to protect the upper part of a wearer's head against injury from falling objects. The device is composed by an external polycarbonate shell and by an internal EPS shell; another protective padding, placed between a comfort padding and the internal shell in the top position, is provided to give more performances against impacts to the top of the helmet. This helmet is equipped with a buckle-type regulator (rear slider) positioned in the internal part (harness) that permits the adjustment of the head size from 56 cm to 61 cm.




